ORDINANCE AMENDING CERTAIN SECTIONS OF CHAPTER 143 OF THE CITY CODE KNOWN AS "MUNICIPAL SOLID WASTE STREAM ORDINANCE OF THE CITY OF ATLANTIC CITY" REGULATING BULK ITEMS

WHEREAS, the collection of certain bulk items, defined as refrigerators, stoves, washers, dryers, household appliances, furniture and similar large items have, due to excessive volumes, have become problematic for regular curbside pickup.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Atlantic City Code Chapter 143, Garbage, Rubbish and Refuse shall be amended as follows:

- **SECTION 1.** Chapter 143-28 (Bulk Items), subsection B shall be amended to read as follows:
- The City shall be responsible for the curbside pick-up of those bulk items weighing В. less than 300 pounds. The City shall not be responsible for the collection of such bulk items weighing more than 300 pounds. No person shall be allowed to place out more than three (3) bulk items per collection cycle. Any person wishing to dispose of said items over 300 pounds must hire a private collector.
- SECTION 2. The remainder of all other sections and subsections of the aforementioned ordinance not specifically amended by this ordinance shall remain in full force and effect.
- SECTION 3. All other ordinances in conflict with or inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.
- **SECTION 4.** If any portion of this ordinance is adjudged unconstitutional or invalid by a court of competent jurisdiction, such judgment shall not affect or invalidate the remainder of this ordinance but shall be confined in its effect to the provision directly involved in the controversy in which such judgment shall have been rendered.

SECTION 5. This ordinance shall become effective twenty (20) days after final passage and advertisement thereof as required by law.
