Council Members MARSHALL, RANDOLPH, SHABAZZ & WEEKES Present the following Ordinance:

## AN ORDINANCE AMENDING CHAPTER 98 OF THE CODE OF THE CITY OF ATLANTIC CITY WHICH REGULATES BOARDWALK TRAMS

**Section 1:** City Code Chapter 98 of the Code of the City of Atlantic City shall be amended as follows:

### § 98-4. Contactor's responsibilities.

O. Historic Boardwalk tram tours for the general public may be added to the schedule ~~from October 15 through May 15 year round.~~ Specific guidelines will be set forth in the bid specifications and in the contract.

### § 98-5. Tram operating procedures.

J. Boardwalk tram fares shall be as follows:

- (1) Boardwalk tram fares shall be \$4-~~\$5~~ one way for adults and \$2 ~~\$3~~ one way for a child.
- (2) All-day fares shall be \$10 ~~\$13~~ for an adult and \$5 ~~\$7~~ for a child.

### § 98-6. Tram operators: applications and qualifications.

~~A. No person shall operate a Boardwalk tram unless a Boardwalk tram operator or Boardwalk tram conductor application is submitted to the Mercantile Division for the issuance of a license on a form provided by the City, containing the following:~~

- ~~(1) Application fee of \$100 (initial application); renewal application fee is \$60;~~
- ~~(2) Proof of citizenship;~~
- ~~(3) Photo license fee: \$10 (replace of lost or stolen license is \$15); and~~
- ~~(4) Fingerprint application fee: \$20 for criminal background checks.~~

B. Each conductor must be 17 years of age. Each operator shall produce a valid and current New Jersey commercial driver’s license (“CDL) in his or her name and must be at least 21 years of age. Applicants must be of sound mind and body with proven ability to manage the Boardwalk tram safely. All conductors and operators shall be employees of the tram company and not private vendors or contractors.

~~C. Each operator and conductor shall submit to testing for addiction for the use of narcotics or intoxicating liquors and shall subject to annual drug testing at a facility selected by the City at the cost of the operator and conductor. The City may also require random drug testing at the discretion of the Director.~~

~~I. The applicant must answer all questions on the application form completely and truthfully and shall sign and sweat or attest to the accuracy of the statements made.~~

~~J. The applicant shall have a written promise of employment from the contractor attached to his or her application.~~

~~M. Upon the satisfactory fulfillment of all necessary requirements, there shall be issued by the City to the applicant a Boardwalk tram operator's license which shall contain the photograph and signature of the operator. It shall be unlawful to remove or obliterate any official entry upon said license. The Boardwalk tram operator's license shall be valid for one year. The Boardwalk tram operator's license shall be of such form and style as the Director prescribes, with the driver's license number from the State of New Jersey and the word "Operator" appearing clearly thereon, which shall be constantly and clearly displayed on the outside of the operator's uniform when engaged in driving a commercial vehicle. The Boardwalk tram conductor's license shall be of such form and style as the Director prescribes.~~

**Section 2.** All Ordinances or parts of Ordinances inconsistent with any of the terms of this Ordinance are hereby repealed to the extent of such inconsistency or inconsistencies.
