A local law amending <u>Chapter 168</u>, "Vehicles and <u>Traffic</u>," of the Village Code, to <u>authorize a stop sign on Locust Avenue at intersection with North</u> <u>Washington Street</u>

Section 1. Legislative Findings and Intent. The Board of Trustees (the "Board") of the Village of Baxter Estates (the "Village"), has determined that the peace, good order, health, safety and welfare of the Village and its residents will be furthered by the installation of a stop sign on Locust Avenue at its intersection with North Washington Street. The western terminus of Locust Avenue is its intersection with North Washington, while the southern terminus of North Washington is that same intersection. Visibility for cars approaching the intersection from either road is limited by vegetation and structures on the improved parcel at the northeast corner of the intersection, a circumstance that is compounded by the narrow width of North Washington. To address safety concerns for both pedestrians and vehicles and their occupants, the Board has

determined to install a stop sign on Locust Avenue at the north-east corner of its intersection with North Washington.

Section 2. Section 168-12, "Stop intersections," of Chapter 168, "Vehicles and Traffic," of the Code of the Village of Baxter Estates, is hereby amended to include the following entries, immediately below the existing entries for Locust Avenue, such entries to read in their entirety as set forth below, each to be under the relevant existing headings
Stop Sign On Direction of Travel At intersection of:

"Locust Avenue

West

North Washington"
