

**VILLAGE OF BANNOCKBURN**

**ORDINANCE NO. 2023- 13**

**AN ORDINANCE AUTHORIZING THE SALE OF CERTAIN SURPLUS PERSONAL PROPERTY OWNED BY THE VILLAGE OF BANNOCKBURN (DESK, FIRE EXTINGUISHER, AEDS, TELEVISION, BODY CAMERAS, BATTERIES, RADIOS AND OTHER ELECTRONIC EQUIPMENT)**

**WHEREAS**, the Village of Bannockburn (the "Village") is the owner of assets as detailed in Attachment A (the "Property"); and

**WHEREAS**, the Village desires to dispose of the Property; and

**WHEREAS**, pursuant to 65 ILCS 5/11-76-4, the President and Board of Trustees of the Village find that the Property is no longer necessary or useful to the Village, and the best interests of the Village will be served by its sale, trade-in, donation and/or disposal;

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BANNOCKBURN**, as follows:

**SECTION ONE:** **Recitals.** The foregoing recitals are incorporated into and made a part of this Ordinance by this reference.

**SECTION TWO:** **Transfer of Property.** Pursuant to 65 ILCS 5/11-76-4, the President and Board of Trustees of the Village authorize the sale, trade-in, donation and/or disposal of the Property.

**SECTION THREE:** **Authority of the Village Manager.** The Village Manager is hereby authorized to dispose of the Property by any lawful means. Upon the disposal of the Property, the

Village Manager is authorized and directed to remove the net value said assets from the financial records.

**SECTION FOUR:** **Effective Date.** This Ordinance shall be in full force and effect upon its passage, approval, and publication in pamphlet form in the manner provided by law.


