PROPOSED LOCAL LAW TO AMEND CHAPTER 117, ARTICLE III OF THE CODE OF THE TOWN OF BEDFORD

A LOCAL LAW to amend Chapter 117, Article III, of the Code of the Town of Bedford regarding parking restrictions, time limits, and exceptions.

BE IT ENACTED by the Town Board of the Town of Bedford as follows:

<u>Section 1.</u> Legislative Intent.

This local law is intended to repeal Chapter 117, Article III, Section 117-12, entitled "Parking restrictions and time limits; exceptions," Subsection D of the Town Code which presently provides an exception for the time limits in which persons may park in Lot 2, 190 Katonah Avenue without charge and without a required parking permit.

Section 2. Authority.

This Local Law is adopted pursuant to the provisions of the New York State Municipal Home Rule Law.

Section 3. Amendment.

Chapter 117 of the Town Code of the Town of Bedford, Article III, Section 117-12 entitled "Parking restrictions and time limits; exceptions," is hereby amended to repeal Subsection D as follows:

- § 117-12 Parking restrictions and time limits; exceptions.
- A. Except where otherwise posted, the hours during which parking permits shall be required or parking in restricted parking areas shall be subject to metered parking shall be restricted to weekdays from 5:00 a.m. to 6:00 p.m., except for the following holidays: New Year's Day, Martin Luther King Day, President's Day, Memorial Day, July Fourth, Labor Day, Veterans Day, Thanksgiving Day and Christmas Day.

- B. Notwithstanding the foregoing restrictions in § 117-12A above, parking in any restricted parking areas under this article shall be allowed without charge and without a parking permit Monday through Thursday, from the hours of 6:00 p.m. to 5:00 a.m. or on any of the holidays listed therein, for vehicles belonging to Town residents (as defined below) with decals or other appropriate identification issued by the Parking Bureau.
- C. Unless otherwise posted, parking in restricted areas under this article shall be permitted by all persons without charge and without a parking permit from Friday at 6:00 p.m. through Monday at 5:00 a.m. and on all holidays listed in § 117-12A above.
- D. All persons parking vehicles in any restricted areas listed in § 117-9 above shall be required to follow all posted limitations and restrictions with respect to parking in specific locations.

<u>Section 4.</u> Ratification, Re-adoption and Confirmation.

Except as specifically modified by the amendments contained herein, Chapter 117, Article III of the Code of the Town of Bedford are otherwise to remain in full force and effect and are otherwise ratified, readopted and confirmed.

Section 5. State Environmental Quality Review Act

Pursuant to 6 NYCRR 617.5 (26) and (33) this Local Law is classified as a Type II action which requires no further review under the New York State Environmental Quality Review Act.

Section 6. Numbering for Codification

It is the intention of the Town of Bedford and it is hereby enacted that the provisions of this Local Law shall be included in the Code of the Town of Bedford; that the sections and subsections of this Local Law may be re-numbered or re-lettered by the Codifier to accomplish such intention; that the Codifier shall make no substantive changes to this Local Law; that the word "Local Law" shall be changed to "Chapter," "Section" or other appropriate word as required for codification; and that any such rearranging of the numbering and editing shall not affect the validity of this Local Law or the provisions of the Code affected thereby.

Section 7. Severability

The provisions of this Local Law are separable and if any provision, clause, sentence, subsection, word or part thereof is held illegal, invalid or unconstitutional, or inapplicable to any person or circumstance, such illegality, invalidity or unconstitutionality, or inapplicability shall not affect or impair any of the remaining provisions, clauses, sentences, subsections, words or parts of this Local Law or their petition to other persons or circumstances. It is hereby declared to be the legislative intent that this Local law would have been adopted if such illegal, invalid or unconstitutional provision, clause, sentence, subsection, word or part had not been included therein, and if such person or circumstance to which the Local Law or part hereof is held inapplicable had been specifically exempt there from.

Section 8. Effective Date

This local law shall take effect immediately upon filing with the Office of the Secretary of State.
