

TOWNSHIP OF BORDENTOWN

ORDINANCE NO. 2024-02

AN ORDINANCE ESTABLISHING THE 2024 SALARY RANGES FOR EMPLOYEES OF THE TOWNSHIP OF BORDENTOWN NOT COVERED BY A COLLECTIVE BARGAINING AGREEMENT

BE IT ORDAINED by the Township Committee of the Township of Bordentown, County of Burlington, State of New Jersey that the 2024 Salary Ordinance of the Township of Bordentown be adopted in the form following:

SECTION 1: That the salary or compensation range for certain officers, permanent employees and provisional employees of the Township of Bordentown are as follows:

SECTION 2. Effective date/effective duration. This ordinance shall take effect immediately upon final passage and publication according to law, and the provisions thereof shall be effective as of January 1, 2023, and shall remain in effect until such time as amendments are required. No rights are created beyond the effective period of this ordinance.

SECTION 3. Repealer. All ordinances and parts of ordinances inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

SECTION 3. Severability. In the event that any portion of this ordinance is determined to be invalid, such determination shall not affect the remaining portions of the ordinance, which are hereby declared to be severable.
