TOWNSHIP OF BORDENTOWN

ORDINANCE NO. 2024-04

AN ORDINANCE TO AMEND THE CODE OF THE TOWNSHIP OF BORDENTOWN, CHAPTERS 178, 260 AND 283 BY REPEALING THE LICENSING REQUIREMENTS OF AUTOMATIC GAMING AND AMUSEMENT DEVICES AND VENDING MACHINES

WHEREAS, the Code of The Township of Bordentown currently regulates automatic gaming and amusement devices and vending machines by requiring licenses; and

WHEREAS, New Jersey law requires vendors operating coin-operated vending machines to register with the State for tax purposes; and

WHEREAS, it is the recommendation of Township administration that local oversight of licensing automatic gaming and amusement devices and vending machines be eliminated; and

WHEREAS, the Township Committee concurs with the recommendations of the Township Administration.

NOW THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Bordentown in the County of Burlington and State of New Jersey as follows:

Section 1. The Code of the Township of Bordentown is hereby amended by deleting:

- Article I, Automatic Gaming and Amusement Devices consisting of §178-1 through §178-9 of Chapter 178, Amusements.
- §260-12 of Chapter 260, Fee Schedule.
- §260-22 of Chapter 260, Fee Schedule.
- Article I, Food and Beverage Vending Machines consisting of §283-1 through §283-4 of Chapter 283, Food and Food Establishments

<u>Section 2</u>. Repealer. Any and all ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.

<u>Section 3</u>. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable to any reason, then the Township Committee hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that is allows the Township to meet the goals of the Ordinance.

Section 5. Effective date. This ordinance shall become effective as soon as permitted by law.
