ORDINANCE OF THE TOWNSHIP OF DEPTFORD AUTHORIZING THE NEGOTIATION, ACQUISITION AND PURCHASE OF CERTAIN LANDS KNOWN AS BLOCK 226, LOT 3 THAT ARE LANDS TO BE DEDICATED TO THE PUBLIC

WHEREAS, the Township of Deptford was advised of the interest of the owner of property known as Block 226, Lot 3 on the tax map of Deptford Township (the "Property") to sell the lands approximating 4.38 acres to the Township the location of a future school or community center or other permissible government use; and

WHEREAS, the acquisition of the Property is in the Township's best interests and will provide additional educational, recreational and community development capacity for the residents of Deptford Township.

WHEREAS, the Township Council directs that there are sufficient funds to purchase the property; and

WHEREAS, the Diocese of Camden, owners of the property and the Township of Deptford have agreed to the sales price in the sum of Ninety Thousand (\$90,000.00) Dollars, pursuant to the terms and conditions of an Agreement being negotiated between the owner of the Property and the Township; and

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Deptford that the purchase and acquisition of the Property by the Township is hereby approved, subject, however, to due diligence performed on behalf of the Township; and

BE IT FURTHER RESOLVED that the Township Solicitor is hereby authorized to negotiate the terms and conditions of the purchase agreement directly with the owner and their representatives, forthwith after the adoption hereof and the Township Manager, or other appropriate Township official is authorized to execute a purchase agreement and to take all other actions necessary for this transaction.
