

**ORDINANCE OF THE TOWNSHIP OF DEPTFORD, COUNTY OF GLOUCESTER,  
NEW JERSEY, APPROPRIATING \$725,000 FROM THE CAPITAL IMPROVEMENT FUND  
FOR VARIOUS IMPROVEMENTS TO FASOLA PARK**

**BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF DEPTFORD,  
COUNTY OF GLOUCESTER, STATE OF NEW JERSEY, AS FOLLOWS:**

**Section 1.** There is hereby appropriated from the Capital Improvement Fund the aggregate sum of \$725,000 for the installation of pickleball courts, parking lot improvements and other various improvements to Fasola Park, together with the acquisition of all materials and equipment and completion of all work necessary therefor or related thereto.

**Section 2.** It is hereby determined and stated that the improvements set forth in Section 1 above are general capital improvements and are not a current expense.

**Section 3.** The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith, and the resolution promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program, as approved by the Director of the Division of Local Government Services, is on file with the Township Clerk and available for inspection.

**Section 4.** All ordinances, or parts of ordinances, inconsistent herewith are hereby repealed to the extent of such inconsistency.

**Section 5.** This ordinance shall take effect after final adoption and publication as required by law.
