ORDINANCE OF THE TOWNSHIP OF DEPTFORD, COUNTY OF GLOUCESTER, STATE OF NEW JERSEY, APPROPRIATING \$1,100,000 FROM THE CAPITAL IMPROVEMENT FUND FOR THE COMPLETION OF VARIOUS IMPROVEMENTS AND THE ACQUISITION OF VARIOUS PIECES OF EQUIPMENT AND TECHNOLOGY

## BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF DEPTFORD, COUNTY OF GLOUCESTER, STATE OF NEW JERSEY, AS FOLLOWS:

Section 1. There is hereby appropriated from the Capital Improvement Fund the aggregate sum of \$1,10,000 for various general improvements as detailed below in the Township of Deptford, County of Gloucester, New Jersey ("Township"), together with the acquisition of all materials and equipment and completion of all work necessary therefor or related thereto.

## Purpose/Improvement **Estimated Total Cost** A. Various Building Improvements and Upgrades to \$300,000.00 Township Buildings, including, but not limited to the Municipal Court Office, Senior Center, Recreation Center together with the acquisition of all materials and equipment and completion of all work necessary therefor or related thereto Acquisition of Information Technology Equipment, B. \$250,000.00 together with the acquisition of all materials and equipment and completion of all work necessary therefor or related thereto Acquisition and Installation of HVAC systems for the C. \$250,000.00 Municipal Building and Public Works Buildings, together with all materials and services for the completion of all work necessary therefor and related thereto D. Various Recreational Improvements, including, but not \$300,000.00 limited to, the Acquisition and Installation of Various Equipment at Various Township Parks, together with the Completion of Various Restroom Facilities at Various Township Parks, together with all materials and equipment and completion of all work necessary therefor or related thereto

Section 2. It is hereby determined and stated that the improvements set forth in Section 1 above are general capital improvements and are not a current expense.

Section 3. The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith, and the resolution promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program, as approved by the Director of the Division of Local Government Services, is on file with the Township Clerk and available for inspection.

Section 4. All ordinances, or parts of ordinances, inconsistent herewith are hereby repealed to the extent of such inconsistency.

Section 5. This ordinance shall take effect after final adoption and publication as required by law.
