ORDINANCE OF THE TOWNSHIP OF DEPTFORD, COUNTY OF GLOUCESTER, STATE OF NEW JERSEY, APPROPRIATING \$200,000 FROM CAPITAL SURPLUS FOR THE ACQUISITION OF PUBLIC WORKS HEAVY EQUIPMENT

BE IT ORDAINED by the Township Council of the Township of Deptford, County of Gloucester, State of New Jersey, as follows:

<u>Section 1.</u> There is hereby appropriated from the Capital Surplus the aggregate sum of 200,000 for the purchase of heavy equipment in the public works department – dump truck in the Township of Deptford, County of Gloucester, New Jersey ("Township"), together with the acquisition of all materials and equipment and completion of all work necessary therefor or related thereto.

Section 2. It is hereby determined and stated that the improvement set forth in Section 1 above is a general capital improvement and is not a current expense.

<u>Section 3.</u> The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith, and the resolution promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program, as approved by the Director of the Division of Local Government Services, is on file with the Township Clerk and available for inspection.

Section 4. All ordinances, or parts of ordinances, inconsistent herewith are hereby repealed to the extent of such inconsistency.

Section 5. This ordinance shall take effect after final adoption and publication as required by law.
