BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF DEPTFORD, COUNTY OF GLOUCESTER, STATE OF NEW JERSEY, AS FOLLOWS:

<u>Section 1.</u> The aggregate amount of \$740,000.00, \$422,000 from the Capital Improvement Fund and \$318,000.00 in grant funding from various sources for various general improvements as detailed below in the Township of Deptford, County of Gloucester, New Jersey ("Township"), together with the acquisition of all materials and equipment and completion of all work necessary therefor or related thereto.
