

ORDINANCE NO. 0. 2. 2007

AN ORDINANCE VACATING A PORTION OF TURKEY HILL ROAD IN THE TOWNSHIP OF DEPTFORD

WHEREAS, as part of Resolution No. R-5-1997 of the Planning Board for the Township of Deptford, regarding Ladd's Landing, a portion of Turkey Hill Road was to be vacated and incorporated into Block 4, Lot 91 currently owned by William and Elizabeth DiPonziano; and

WHEREAS, the vacation of said portion of Turkey Hill Road and its incorporation into Block 4, Lot 91 was not previously effectuated; and

WHEREAS, the Township of Deptford wishes to satisfy the Planning Board's prior resolution and vacate the pertinent portion of Turkey Hill Road so that it can be incorporated in to Block 4, Lot 91; and

WHEREAS, the portion of Turkey Hill Road to be vacated is more fully described in the proposed Legal Description prepared by Alaimo Group, dated November 16, 2006, attached hereto as Exhibit "A";

NOW, THEREFORE, BE IT ORDAINED, that the portion of Turkey Hill Road described in the Legal Description attached hereto as Exhibit "A" is hereby vacated; and

BE IT FURTHER ORDAINED that all rights and privileges now possessed by public utilities, as defined in R.S. 48:2-13, and by any cable television company, as defined in the "Cable Television Act," P.L.1972, c.186, (C.48:5A-1, et seq.), to maintain, repair and replace their existing facilities in, adjacent to, over or under the said portion of Turkey Hill Road, or any part thereof to be vacated, are expressly reserved and excepted from this vacation; and

BE IT FURTHER ORDAINED that the vacated portion of Turkey Hill Road described in Exhibit "A" shall be transferred to the current owners of Block 4, Lot 91 in accordance with the Planning Board's Resolution for Ladd's Landing; and

BE IT FURTHER ORDAINED that this Ordinance shall take effect twenty (20) days after its final passage and publication as provided by law.

- 1) On a curve to the left a radius of 350.00 feet, Delta of 31 degrees 00 minutes

 degrees 43 minutes 24 seconds East, 187.09 feet to the southwest corner to

 Block 4, Lot 91 and the northwesterly right-of-way line of Turkey Hill Road,

 still within the limits of the 70 foot wide mentioned easement, thence along the

- 2) North 45 degrees 13 minutes 42 seconds East, 120.55 feet to a corner in the same, thence
- 3) South 44 degrees 46 minutes 18 seconds East, 50.00 feet to a point corner of Lot 91 and southerly right-of-way line of Turkey Hill Road and the northerly right-of-way line of the New Jersey Turnpike, thence along the same
- 4) South 45 degrees 13 minutes 42 seconds West, 300.83 feet to the point and place of beginning.

Hallowel, Jr., PLS titled "Final Subdivision Plan of Ladd's Landing Section 1" dated November 15, 1996 situate in the Township of Deptford, County of Gloucester and State of New Jersey, and is more particularly described as follows:

BEGINNING at a point on the curved easterly right-of-way line of Ladd's Lane

Corner to and division line of Block 4, Lots 91 and 90, thence extending along said division

line

- North 80 degrees 14 minutes 52 seconds East, 143.01 feet crossing into a 70 foot wide Transcontinental Pipe Line Corporation easement, to a point and corner, thence
- Within the limits of said easement and along the division line of Sections 1 and 2 of Ladd's Landing, South 22 degrees 44 minutes 53 seconds East, 72.37 feet to a point in the southerly right-of-way line of Turkey Hill Road and the northerly right-of-way line of the New Jersey Turnpike (300' wide), thence along the same
