ORDINANCE OF THE TOWNSHIP OF DEPTFORD, COUNTY OF GLOUCESTER, NEW JERSEY, CANCELING CERTAIN FUNDED APPROPRIATION BALANCES HERETOFORE PROVIDED FOR VARIOUS CAPITAL PROJECTS AND REAPPROPRIATING SUCH FUNDED APPROPRIATION BALANCES FOR OTHER CAPITAL PROJECTS

BE IT ORDAINED by the Township Council of the Township of Deptford, County of Gloucester, New Jersey (not less than two-thirds of all the members thereof affirmatively concurring), pursuant to the provisions of the Local Bond Law, Chapter 169 of the Laws of 1960 of the State of New Jersey, as amended and supplemented ("Local Bond Law"), as follows:

<u>Section 1.</u> The following appropriations, remaining as balances in the following bond ordinances (collectively, the "Bond Ordinances"), heretofore adopted by the Township Council of the Township of Deptford, County of Gloucester, New Jersey ("Township"), are hereby cancelled:

Section 2. The sum of \$84,714.00, which represents the funded appropriation canceled in Section 1 hereof, is hereby reappropriated from the Bond Ordinances for: (i) acquisition of police radios in the amount of \$12,257.00; (ii) demolition of an abandoned fire-damaged home in Pine Acres in the amount of \$16,500.00; and (iii) various improvements to Township municipal and recreation facilities, including the acquisition of furniture and equipment in the amount of \$37,803.00; and (iv) various road improvements in the amount of \$18,154.00; together with the acquisition of all materials and equipment and completion of all work necessary therefor or related thereto.

Section 3. The period of usefulness of the purposes referred to in Section 2, within the limitations of the Local Bond Law and according to the reasonable life thereof, is not less than five (5) years.

Section 4. The Capital Budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith, and the resolution promulgated by the Local Finance Board showing full detail of the amended Capital Budget and Capital Program as approved by the Director of the Division of Local Government Services, is on file with the Municipal Clerk and available for inspection.
