## AN ORDINANCE AMENDING THE DEPTFORD TOWNSHIP UNIFIED DEVELOPMENT ORDINANCE (UDO) TO REDUCE INTENSITY IN THE BC ZONES

WHEREAS, the Deptford Township Council desires to reduce intensity in the BC Zones; and

WHEREAS, the Deptford Township Planning Board recommends this action to the Township Council and has amended the Master Plan accordingly;

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Deptford that the Unified Development Ordinance is hereby amended as follows:

## Section 1. Article II Paragraph 6. Definitions

Add in proper alphabetical order:

<u>Department Store:</u> A commercial establishment, which has separate and distinct areas within the structure for the display and sale of differing items, often with changes in décor and furnishing and each department having its own staff and cashiering. These stores are usually on multiple levels.

<u>Discount Store or Club:</u> A single-use building either freestanding or part of a multi-use structure or retail complex characterized by the large size of the store, wide range of products offered, centralized cashiering, and marketing based upon discount pricing.

## Section 2. Article III Paragraph 17.C.2 Revise chart as follows:

Development Tract Size (Acres) Maximum Trip Ends Per Acre

Under 50 acres 18 50 acres or more 16

# Section 3. Article III Paragraph 17.1.C.2. Revise chart as follows:

Development Tract Size (Acres) Maximum Trip Ends Per Acre

Under 100 acres 27 100 acres or more 22.5

## Section 4. Article III Paragraph 17.2 Revise as follows:

### B. Uses add:

- o. Department Stores
- p. Discount Stores not to exceed 100,000 sq. ft. in any configuration including outdoor sales area.

### C. 2 Revise chart as follows:

# Development Tract Size (acres) Maximum Trip Ends Per Acre

Under 100 acres 31.5 Greater than 100 acres 27

## Section 5. Article III Paragraph 17 Revise as follows:

### B. Uses add:

- n. Department Stores
- o. Discount Stores
- C. 3 Change No. 8 to read as follows: Maximum size of single use 75,000 square feet in BC-4 only. Maximum size of discount stores in BC-3 100,000 square feet.

# Section 6. Article III Paragraph 17.1

### B. Uses add:

- g. Department Stores
- h. Discount stores not to exceed 100,000 square feet.
- **Section 7.** Any provisions of any Ordinance inconsistent with the provisions of this Ordinance are hereby repealed.
- **Section 8.** If any sections or provisions of this Ordinance shall be ruled invalid such rule shall apply only to the section or provisions so adjudged and the remainder of this Ordinance shall be deemed valid and effective.

**Section 9.** This Ordinance shall take effect twenty (20) days after adoption and publication pursuant to law.
