# TOWNSHIP OF DEPTFORD, NEW JERSEY

### **ORDINANCE NO.9.10**

REFUNDING BOND ORDINANCE PROVIDING FOR THE REFUNDING OF: (i) THE TOWNSHIP'S OUTSTANDING CALLABLE GENERAL OBLIGATION BONDS, SERIES 1995, DATED DECEMBER 1, 1995; AND (ii) THE TOWNSHIP'S OUTSTANDING CALLABLE GENERAL OBLIGATION BONDS, SERIES 2002, DATED MARCH 1, 2002; AUTHORIZING THE ISSUANCE OF UP TO \$6,300,000 OF REFUNDING BONDS OF THE TOWNSHIP OF DEPTFORD, COUNTY OF GLOUCESTER, NEW JERSEY, TO FINANCE THE COSTS THEREOF; MAKING CERTAIN DETERMINATIONS AND COVENANTS IN CONNECTION THEREWITH; AND AUTHORIZING CERTAIN RELATED ACTIONS IN CONNECTION WITH THE FOREGOING

**BE IT ORDAINED** by the Township Council of the Township of Deptford, County of Gloucester, New Jersey (not less than two-thirds of all the members thereof affirmatively concurring), pursuant to the provisions of the Local Bond Law, Chapter 169 of the Laws of 1960 of the State of New Jersey, as amended and supplemented ("Local Bond Law"), as follows:

<u>Section 1.</u> The Township of Deptford, County of Gloucester, New Jersey ("Township"), is hereby authorized to refund all of its outstanding callable General Obligation Bonds, Series 1995, dated December 1, 1995, in the aggregate principal amount of \$1,100,000, and maturing as follows ("1995 Callable Bonds"):

December 1, 2014	200,000
December 1, 2015	200,000

The exact principal amount of 1995 Callable Bonds to be refunded (which may be less than all of the 1995 Callable Bonds) shall be determined pursuant to a resolution adopted by the Township Council by not less than two-thirds of all the members thereof.

Section 2. The Township is hereby authorized to refund all of its outstanding callable General Obligation Bonds, Series 2002, dated March 1, 2002, in the aggregate principal amount of \$4,735,000, and maturing as follows ("2002 Callable Bonds"; together with the 1995 Callable Bonds, the "Callable Bonds"):

The exact principal amount of 2002 Callable Bonds to be refunded (which may be less than all of the 2002 Callable Bonds) shall be determined pursuant to a resolution adopted by the Township Council by not less than two-thirds of all the members thereof.

<u>Section 3.</u> To effectuate the refunding of up to all of the Callable Bonds, negotiable general obligation refunding bonds of the Township are hereby authorized to be issued in one or more series in an aggregate principal amount not to exceed \$6,300,000 ("Refunding Bonds"), pursuant to the Local Bond Law. The maximum principal amount of Refunding Bonds to be issued and other terms thereof shall be determined pursuant to a resolution adopted by the Township Council by not less than two-thirds of all the members thereof.

<u>Section 4.</u> An aggregate amount not exceeding \$115,000 for the items of expense listed in and permitted by Section 51.b. of the Local Bond Law, N.J.S.A. 40A:2-51.b., has been included in the aggregate principal amount of the Refunding Bonds authorized herein.

<u>Section 5.</u> The purpose of the Refunding Bonds is to effect an interest cost savings for the Township.

<u>Section 6.</u> Each Refunding Bond authorized herein shall be designated, substantially, "Township of Deptford, County of Gloucester, New Jersey, General Obligation Refunding Bond, Series 20\_\_\_" and shall be in the form prescribed and permitted by the Local Bond Law, as Bond Counsel may advise, and as the Township shall approve.

<u>Section 7.</u> The Refunding Bonds may be sold at public or private sale pursuant to a resolution of the Township Council adopted by not less than two-thirds of the full members thereof.

Section 8. The supplemental debt statement provided for in Section 10 of the Local Bond Law, N.J.S.A. 40A:2-10, was duly filed in the office of the Township Clerk prior to the passage of this refunding bond ordinance on first reading and a complete executed duplicate original thereof has been filed in the Office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey.

<u>Section 9.</u> A certified copy of this refunding bond ordinance as adopted on first reading has been filed with the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey prior to final adoption, together with a complete statement in the form prescribed by the Director and signed by the Township Chief Financial Officer as to the outstanding indebtedness to be refunded by the issuance of the Refunding Bonds.

<u>Section 10.</u> All ordinances, or parts of ordinances, inconsistent herewith, including without limitation, Refunding Bond Ordinance 5.10, are hereby repealed to the extent of such inconsistency.

<u>Section 11.</u> This refunding bond ordinance shall take effect twenty (20) days after the first publication thereof after final adoption, as provided by the Local Bond Law, provided that the consent of the Local Finance Board has been endorsed upon a certified copy of this refunding bond ordinance as finally adopted.

## STATEMENT


