

**ORDINANCE APPROPRIATING THE SUM OF \$130,000.00
TO BE USED FOR THE RECONDITION AND/OR OVERHAUL
OF TWO AMBULANCES WITHIN THE TOWNSHIP OF DEPTFORD,
COUNTY OF GLOUCESTER, STATE OF NEW JERSEY**

WHEREAS, the Governing Body desires to authorize the recondition and/or overhaul of two ambulances within the Township of Deptford: and

WHEREAS, sufficient funds are available for said purpose from the Township's Capital Improvement Fund;

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Township Council of the Township of Deptford, County of Gloucester and State of New Jersey, that:

SECTION 1: There is hereby appropriated from the following sources the sum of \$130,000.00 to be used for the following capital project within the Township of Deptford:

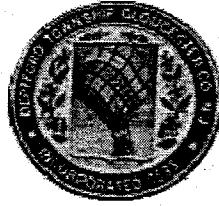

A. Recondition and/or overhaul of two ambulances, together with the acquisition of all materials and equipment and completion of all work necessary therefor or related thereto	\$130,000	\$130,000	5 years

SECTION 2: In connection with the amounts authorized in Section 1, the Township makes the following determinations:

- a) The purpose described in Section 1 is not a Current Expense and is an improvement, which the Township may lawfully make as a general improvement.
- b) The period of usefulness of the purpose described in Section 1 hereof is within the limitations of the Local Bond Law and according to the reasonable life thereof is five (5) years or more.
- c) No debt is authorized by this ordinance.
- d) The capital budget of the Township is hereby amended.

SECTION 3: All ordinances or parts of ordinances that are inconsistent with the terms of this ordinance be and the same are hereby repealed to the extent of their inconsistency.

SECTION 4: This ordinance shall take effect immediately upon proper passage, publication in accordance with law and after final adoption as provided by law.
