Ordinance of the Board of Health of the Township of Deptford Creating a New Subsection to the Health Code to be Entitled – Fees

Be It Ordained by the Board of Health of the Township of Deptford, County of Gloucester and State of New Jersey that the Board of Health Code of the Township of Deptford be amended by adding a new sub-section, BH:17 – Fees, to read as follows:

Section 1. BH:17 Fees

1. BH:17-1 Fees for Birth, Death and Marriage Certificates. A fee of \$20.00 will be charged for each individual birth, death or marriage certificate and a \$10.00 fee will be charged for any additional certificates.

Section 2. Repealer

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

Section 3. Severability

Each section of this Ordinance is an independent section, and the holding of any section or part thereof to be unconstitutional, void or ineffective, shall not be deemed to affect the validity or constitutionality of any other sections or parts hereof.

Be It Further Ordained that this Ordinance shall take effect immediately upon final passage and publication as required by law.
