## ORDINANCE AMENDING THE TOWNSHIP'S SALARY ORDINANCE TO ADD THE POSITION OF TAX SEARCH OFFICER AND TO AMEND THE SALARY RANGE FOR THE POSITION OF TAX COLLECTOR

WHEREAS, if any subsection, sentence, clause, or phrase of this Ordinance is for any reason held to be unconstitutional or invalid in any Court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance; and

WHEREAS, this Ordinance shall take effect upon final passage, approval, and publication, as required by law;

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Township Council of the Township of Deptford, County of Gloucester, State of New Jersey, that the Salary Ordinance of Deptford Township shall be amended to now include the following position and salary ranges:
