## ORDINANCE DEDICATING ACQUIRED LAND IN THE TOWNSHIP OF DEPTFORD, COUNTY OF GLOUCESTER, TO BE TITLED, "DEPTFORD VETERANS PARK"

WHEREAS, in 2012, Deptford Parks and Recreation acquired land from the Deptford School District, in a Shared Service Agreement, formerly known as Oak Valley School Ground, to be set aside for a new park titled, Deptford Veterans Park; and

WHEREAS, at the time of the acquisition, the park was not officially named so therefore Deptford Township began a planning process for the park site in January, 2012; and

WHEREAS, a Veteran's Advisory Committee was selected, open houses presented the design to the community and construction began with completion of the park scheduled for May, 2013; and

WHEREAS, the Deptford Township Mayor & Council received a formal request from the Deptford Veteran's Committee to name the park site, Deptford Veterans Park in honor of all veterans.

**NOW, THEREFORE BE IT ORDAINED,** by the Mayor and Council of Deptford Township, along with Deptford Parks and Recreation, is hereby authorized to accept Deptford Veterans Park as the name for the land acquired and will forever be called, "Deptford Veterans Park".

This ordinance shall take effect immediately upon proper passage and publication in accordance with law and after final adoption as provided by law.
