## ORDINANCE AUTHORIZING THE ACCEPTANCE OF A GIFT OF REAL PROPERTY ALONG CAULFIELD AVENUE, BLOCK 5.04, LOT 75 FROM LOCUST GROVE PROPERTY

- 4. The Township Solicitor is authorized to obtain title insurance on the property and to prepare and file the necessary deed and any other documents.
- 5. This Ordinance shall take effect twenty (20) days after final passage and publication in accordance with applicable law.
