AN ORDINANCE OF THE TOWNSHIP OF DEPTFORD AMENDING ORDINANCE NO. 0.16.12 FOR LANDLORD TENANT

WHEREAS, the Township of Deptford has previously amended the Township Code to adopt additional measures for the inspection of and registration of rental properties, most recently through Ordinance No's O.13.12 and O.16.12; and

WHEREAS, it has come to the attention of Mayor and Council that in order to better effectuate these additional measures, further revision to the Township Code is necessary; and

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Township Council of the Township of Deptford, in the County of Gloucester and State of New Jersey, that Ordinance No. 0.16.12 shall be amended in the following ways:

- Section 1. In the section entitled "§Registration and licensing; change of occupancy; term; initial registration" a clause shall be added which reads "A landlord/owner shall be exempt from the registration, licensing, and inspection requirements of this ordinance if it can be demonstrated that the property or unit they own is not used as a rental property. In order to qualify for this exemption, the landlord/owner must complete and submit an "Affidavit of Non-Rental Property" which shall be available in the office of the Municipal Clerk. This "Affidavit of Non-Rental Property" must be completed and submitted in accordance with registration deadlines and submission dates as contained in this ordinance."
- Section 2. In the section entitled "§Fees" section 1(b)(1), 1(b)(2), 1(b)(3) and 1(b)(4) shall be deleted and instead section 1(b) shall simply read "Apartment complex: \$75.00 per unit.".
- Section 3. In the section entitled "§Fees" section 1(d) shall be deleted in its entirety.
- Section 4. Repealer. All ordinances or parts of ordinances inconsistent or in conflict with this Ordinance are hereby repealed as to said inconsistencies and conflict.
- Section 5. Severability. If any section, part of any section, or clause or phrase of this ordinance is for any reason held to be invalid or unconstitutional, such decision shall not effect the remaining provisions of this ordinance. The governing body of the Township of Deptford declares that it would have passed the ordinance and each section and subsection thereof, irrespective of the fact that any one or more of the subsections, sentences, clauses or phrases may be declared unconstitutional or invalid.

Section 6. Effective Date. The ordinance shall take effect immediately upon passage and publication according to law.
