ORDINANCE APPROPRIATING FUNDS FOR IMPROVEMENTS IN THE TOWNSHIP OF DEPTFORD IN THE COUNTY OF GLOUCESTER, STATE OF NEW JERSEY

WHEREAS, the Governing Body of the Township of Deptford, County of Gloucester, New Jersey ("Township") desires to authorize various capital improvements to the Township's municipal building; and

WHEREAS, there are sufficient funds available for said purpose from the Township's Capital Fund Balance;

NOW, THEREFORE, BE IT ORDAINED AND ENACTED, by the Township Council of the Township of Deptford, County of Gloucester, and State of New Jersey, that:

<u>Section 1</u>: There is hereby appropriated from the following sources the sum of \$50,000.00 to be used for the following capital project within the Township of Deptford:

A.,	Various capital improvements to the Township's Municipal Building; together with the acquisition of all materials and equipment and completion of all work necessary therefor or related thereto, all as more particularly described in the plans and specifications on file in the office of the Township Clerk	\$50,000	\$50,000

Section 2. In connection with the amounts authorized in Section 1, the Township makes the following determinations:

- a) The purpose described in Section 1 is not a Current Expense and is an improvement, which the Township may lawfully make as a general improvement.
- b) The period of usefulness of the proposed described in Section 1 hereof is within the limitations of the Local Bond Law and according to the reasonable life thereof is five (5) years or more.
- c) No debt is authorized by this ordinance.
- d) The capital budget of the Township is hereby amended.

Section 3. All ordinances or parts of ordinances that are inconsistent with the terms of this ordinance be and the same are hereby repealed to the extent of their inconsistency.

<u>Section 4</u>. This ordinance shall take effect immediately upon proper passage, publication in accordance with law and after final adoption as provided by law.
