ORDINANCE OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF DEPTFORD APPROPRIATING FUNDS FOR THE ACQUISTION AND INSTALLATION OF COMPUTER INFRASTRUCTURE

WHEREAS, there exists a need to enhance the performance of the Township's computer systems to meet the needs of current technology and to expand its capacity to retain information as is required by the State of New Jersey; and

WHEREAS, Mayor and Council of Deptford Township desires to authorize the acquisition and installation of computer infrastructure for the Township's computer server and network; and

WHEREAS, the Township's Chief Financial Officer has certified that sufficient funds exist for this purpose.

BE IT ORDAINED by the Mayor and Council of the Township of Deptford on this 5th day of August, 2013 as follows:

1. There is hereby appropriated from the following sources the sum of \$165,000.00 to be used for the following capital project within the Township of Deptford:

Purpose/Improvement	Estimated Total Cost	Capital Fund Balance
Acquisition and installation of computer infrastructure; together with the acquisition of all materials and equipment and completion of all work necessary therefor or related thereto, all as more particularly described in the plans and specifications on file in the office of the Township Clerk.	\$165,000	\$165,000

- 2. In connection with the amounts authorized in 1 above, the Township makes the following determinations:
 - a) The purpose described in 1 above is not a Current Expense and is an improvement, which the Township may lawfully make as a general improvement.
 - b) The period of usefulness of the proposed described in 1 above is within the limitations of the New Jersey Local Bond Law N.J.S.A. 40A:2-1 *et seq.* and according to the reasonable life thereof is five (5) years or more.

- c) No debt is authorized by this Ordinance.
- d) The capital budget of the Township is hereby amended.
- 3. All ordinances or parts of Ordinances that are inconsistent with the terms of this Ordinance be and the same are hereby repealed to the extent of their inconsistency

BE IT FURTHER ORDAINED that this Ordinance shall take effect upon passage and publication as required by law.
