

**ORDINANCE OF THE TOWNSHIP OF DEPTFORD AMENDING ORDINANCE
NO. O.12.13 WHICH REGULATES OUTDOOR AND OPEN BURNING**

WHEREAS, the Township of Deptford has previously amended the Township Code to adopt measures for the regulation of outdoor and open burning through Ordinance No. O.12.13; and

WHEREAS, it has come to the attention of Mayor and Council that in order to better effectuate these regulations, further revision to the Township Code is necessary; and

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Township Council of the Township of Deptford, in the County of Gloucester and State of New Jersey, that Ordinance No. O.12.13 shall be amended in the following ways:

Section 1. In the section entitled "II. Applicability" a section (D) shall be added which reads "This Article shall not apply to Underwriters Laboratory ("UL") approved wood or gas burning units."

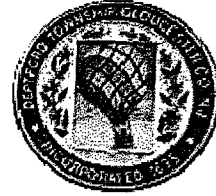
Section 2. In the section entitled "VIII. Wood or gas burning units," the second and third paragraphs shall be deleted in their entirety.

Section 3. In the section entitled "VIII. Wood or gas burning units" section (C) shall be edited in its entirety to read "The wood or gas burning unit shall be limited to a maximum of 48 inch diameter and 24 inch height."

Section 4. Repealer. All ordinances or parts of ordinances inconsistent or in conflict with this Ordinance are hereby repealed as to said inconsistencies and conflict.

Section 5. Severability. If any section, part of any section, or clause or phrase of this ordinance is for any reason held to be invalid or unconstitutional, such decision shall not effect the remaining provisions of this ordinance. The governing body of the Township of Deptford declares that it would have passed the ordinance and each section and subsection thereof, irrespective of the fact that any one or more of the subsections, sentences, clauses or phrases may be declared unconstitutional or invalid.

Section 6. Effective Date. The ordinance shall take effect immediately upon passage and publication according to law.

AN ORDINANCE AUTHORIZING THE COUNTY EXECUTIVE AND SHERIFF TO EXECUTE TWO INTERGOVERNMENTAL AGREEMENTS RELATING TO COMBATING HUMAN TRAFFICKING INCLUDING 1) A MEMORANDUM OF UNDERSTANDING WITH THE UNITED STATES ATTORNEYS OFFICE, ST. LOUIS COUNTY AND OTHERS AND 2) AN AGREEMENT WITH ST. LOUIS COUNTY TO PROVIDE A DETECTIVE TO THE HUMAN TRAFFICKING TASK FORCE AND AUTHORIZING THE RECEIPT OF FUNDS IN AN AMOUNT UP TO \$69,219 FOR REIMBURSEMENT OF SALARY AND BENEFITS OF THAT DETECTIVE THROUGH A GRANT AWARD TO ST. LOUIS COUNTY UNDER THE ENHANCED COLLABORATIVE MODEL TO COMBAT HUMAN TRAFFICKING (CFDA #16.320), AND FURTHER, BY AMENDING BUDGET ORDINANCE 13-092 BY CREATING A NEW REVENUE LINE ITEM AND SUPPLEMENTAL APPROPRIATIONS WITHIN THE 2014 SHERIFF'S DEPARTMENT BUDGET AND FURTHER AMENDING ORDINANCE 13-092 RELATING TO A POSITION WITHIN THE SHERIFF'S DEPARTMENT CRIMINAL INVESTIGATIONS DIVISION

WHEREAS, according to the Department of Justice, Missouri (specifically the Western District) was one of the first areas in the country to prosecute human trafficking cases

and has been extremely aggressive in identifying and prosecuting human trafficking by criminals who advertise online offering services, sexual in nature, to be performed by those they have enslaved for that purpose; and

WHEREAS, this aggressive identification and prosecution of human trafficking has resulted in the St. Louis area also recognizing it is an “intense trafficking jurisdiction” with regard to human trafficking of forced sex or labor slaves; and

WHEREAS, the Eastern District of Missouri is increasing its efforts in the fight against human trafficking, specifically the United States Attorney’s Office, the St. Louis County Police Department, St. Charles County Sheriff’s Department and the St. Louis RESTeam (Rescue Service Team) are working together to serve victims and enhance the prosecution of human trafficking crimes in the Eastern District of Missouri; and

WHEREAS, a grant, titled the Enhanced Collaborative Model to Combat Human Trafficking, was established in 2010 and awarded to six applicant groups across the United States in 2013 to combat human trafficking in 2014 and 2015; and

WHEREAS, the grant is intended to identify and prosecute trafficking, as well as help train law enforcement and other personnel to teach them what to look for and to change perceptions, both in law enforcement and the public so that victims, mostly girls ages 14-17, who are forced and coerced into

human traffic, can be identified and assisted and their traffickers prosecuted; and

WHEREAS, the St. Charles County Sheriff's Department applied for and has been awarded grant funds under the U.S. Department of Justice's Enhanced Collaborative Model to Combat Human Trafficking (CFDA #16.320), which grant was awarded to St. Louis County, St. Charles County, and other entities fighting human trafficking; and

WHEREAS, the grant award provides for funding a position of Detective to serve on the St. Louis County Multi-Jurisdictional Human Trafficking Task Force to ensure law enforcement is adequately trained in protocols to combat human trafficking, and to provide leadership in the development of law enforcement agency coordinated response to human trafficking case investigations, to investigate human trafficking and to provide on-going community education on this issue; and

WHEREAS, the grant funding authorized for this position to combat human trafficking is funded through September 30, 2015, with the ability to extend the current grant through December 31, 2015; and

WHEREAS, the grant is expected to be reauthorized beyond 2015; and

WHEREAS, Chapter 70, Revised Statutes of Missouri, authorizes an intergovernmental agreement between political subdivisions for the purposes herein set out; and

WHEREAS, the St. Charles County Charter Art. VI, Section 6.206.1 (2012) provides that the County Council may by

ordinance make supplemental appropriations if the County Executive certifies that there are available for appropriation revenues in excess of those estimated in the budget; and

WHEREAS, the County Executive has certified funds are available for this budget amendment in Exhibit A attached hereto; and

WHEREAS, the St. Charles County Charter Article VI, Section 6.208 (2012) authorizes the County Council to provide by ordinance any and all procedures for administering the budget that are necessary and that do not conflict with the language contained in the Charter.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNTY COUNCIL OF ST. CHARLES COUNTY, MISSOURI, AS FOLLOWS:

Section 1. The County Executive and Sheriff are hereby authorized to execute the Intergovernmental Agreements concerning human trafficking as follows: 1) the Memorandum of Understanding for the Enhanced Collaborative Model to Combat Human Trafficking Grant attached as Exhibit B between the United States Attorney's Office, St. Louis County Police, St. Charles County, the International Institute, Legal Services of Eastern Missouri and the YWCA, and 2) the St. Louis County Multi-Jurisdictional Human Trafficking Task Force Contract attached as Exhibit C between St. Louis County on behalf of their Police Department and St. Charles County, as well as future agreements under this program which meet the terms of Section 135.410, OSCCMo., relating to grants.

- Section 2. The intergovernmental agreement shall be substantially the same in form and content as those attached hereto as Exhibits B and C and incorporated herein by reference.
- Section 3. Compliance with all the terms of the agreements shall be the responsibility of the Sheriff.
- Section 4. The budget of St. Charles County, Missouri, for fiscal year 2014 as adopted by Ordinance 13-092, in the budget of the General Fund is hereby amended by creating a new revenue line item 001-33164, Combat Human Trafficking with a beginning allocation of \$69,219.00.
- Section 5. The budget of St. Charles County, Missouri for fiscal year 2014 as adopted by Ordinance 13-092, is hereby amended within the budget of the Sheriff Criminal Investigations Division by authorizing one (1) new grant supported position of Detective, Pay Grade 11, for a total of two (2) such positions for the purpose of full time assignment to the Multi-Jurisdictional Human Trafficking Task Force.
- Section 6. The budget of St. Charles County, Missouri, for fiscal year 2014 as adopted by Ordinance 13-092, in the budget of the Sheriff Criminal Investigations Division is hereby amended by deleting the original allocation of \$1,949,888 in personnel line item 0018300-41210, Permanent - Full Time, and inserting in lieu thereof the amended amount of \$1,996,897 (an increase of \$47,009).
- Section 7. The budget of St. Charles County, Missouri, for fiscal year 2014 as adopted by Ordinance 13-092, in the budget of the Sheriff Criminal Investigations Division is hereby amended by deleting the original allocation of \$338,663 in personnel

line item 0018300-42110, Health Insurance, and inserting in lieu thereof the amended amount of \$348,837 (an increase of \$10,174).

- Section 8. The budget of St. Charles County, Missouri, for fiscal year 2014 as adopted by Ordinance 13-092, in the budget of the Sheriff Criminal Investigations Division is hereby amended by deleting the original allocation of \$21,561 in personnel line item 0018300-42120, Dental Insurance, and inserting in lieu thereof the amended amount of \$22,281 (an increase of \$720).
- Section 9. The budget of St. Charles County, Missouri for fiscal year 2014 as adopted by Ordinance 13-092, in the budget of the Sheriff Criminal Investigations Division is hereby amended by deleting the original allocation of \$3,015 in personnel line item 0018300-42130, Life Insurance, and inserting in lieu thereof the amended amount of \$3,089 (an increase of \$74).
- Section 10. The budget of St. Charles County, Missouri for fiscal year 2014 as adopted by Ordinance 13-092, in the budget of the Sheriff Criminal Investigations Division is hereby amended by deleting the original allocation of \$6,045 in personnel line item 0018300-42140, Disability, and inserting in lieu thereof the amended amount of \$6,247 (an increase of \$202).
- Section 11. The budget of St. Charles County, Missouri for fiscal year 2014 as adopted by Ordinance 13-092, in the budget of the Sheriff Criminal Investigations Division is hereby amended by deleting the original allocation of \$146,041 in personnel line item 0018300-42200, Social Security Contributions, and inserting in lieu thereof the amended amount of \$149,376 (an increase of \$3,335).

Section 12. The budget of St. Charles County, Missouri for fiscal year 2014 as adopted by Ordinance 13-092, in the budget of the Sheriff Criminal Investigations Division is hereby amended by deleting the original allocation of \$243,566 in personnel line item 0018300-42300, Retirement Contributions, and inserting in lieu thereof the amended amount of \$245,328 (an increase of \$1,762).

Section 13. The budget of St. Charles County, Missouri for fiscal year 2014 as adopted by Ordinance 13-092, in the budget of the Sheriff Criminal Investigations Division is hereby amended by deleting the original allocation of \$70,725 in personnel line item 0018300-42330, Deferred Compensation Match, and inserting in lieu thereof the amended amount of \$76,648 (an increase of \$5,923).

Section 14. The budget of St. Charles County, Missouri for fiscal year 2014 as adopted by Ordinance 13-092, in the budget of the Sheriff Criminal Investigations Division is hereby amended by deleting the original allocation of \$741 in personnel line item 0018300-42910, Employee Assistance Program, and inserting in lieu thereof the amended amount of \$761 (an increase of \$20).

Section 15. This ordinance shall be in full force and effect from and after the date of its passage and approval and such agreement shall be valid upon its lawful execution by each governmental entity entering into such agreement as required by Chapter 70 of the Revised Statutes of Missouri.

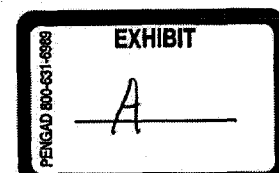

By this correspondence I hereby certify that, pursuant to Section 6.206.1 of the St. Charles County Home Rule Charter, there is available for appropriation additional revenues in excess of those estimated in the adopted 2014 Sheriff's Department budget in the amount of \$69,219.00 for the purpose of a supplemental appropriation.

These additional revenues are due to funds from a new grant award under the Enhanced Collaborative Model to Combat Human Trafficking (CFDA # 16.320) in excess of revenues budgeted in the 2014 County Budget. These additional funds will be received from St. Louis County and will be credited to new revenue account 001-33164 Combat Human Trafficking Grant.

I am also recommending a supplemental appropriation totaling \$69,219.00 to the Sheriff's Department budget. This appropriation would be used for the purpose of funding a new Detective position in the Criminal Investigation Division of the Sheriff's Department. Should the St. Charles County Council approve this supplemental appropriation, the amount of \$69,219.00 would be allocated to the accounts shown in the accompanying attachment.



Accordingly, I am requesting that the St. Charles County Council approve this supplemental appropriation ordinance of the Sheriff's Department for the purpose described above. I appreciate your favorable consideration of this request.

Memorandum of Understanding

This memorandum of understanding (MOU) is among the U.S Attorney's Office and those entities funded under the Enhanced Collaborative Model to Combat Human Trafficking (CFDA #16.320): 1) St. Louis County Police Department, 2) St. Charles County Sheriff's Department, 3) International Institute of St. Louis, 4) Legal Services of Eastern Missouri, and 5) YWCA St. Louis Regional Sexual Assault Center. Responsibilities outlined below are accordant with the Enhanced Collaborative Model to Combat Human Trafficking.

The overall goal of the award is as follows: Strengthen the existing multi-disciplinary, multi-jurisdictional approach to dramatically reduce human trafficking in the Eastern District of Missouri, by rescuing survivors, prosecuting traffickers, and enhancing prevention methods to protect vulnerable individuals.

This goal will be achieved through the following objectives:

1. Identify victims of human trafficking and provide a comprehensive array of restorative services
2. Collaborate with federal, state and local law enforcement, and other entities to enhance service delivery
3. Conduct training and outreach activities to improve the community response to human trafficking

US Attorney's Office agrees to the following:

- Lead the multi-disciplinary effort to combat human trafficking, including recruitment of additional task force members from local and federal law enforcement and victim service agencies
- Coordinate community education, trainings, and outreach
- Prosecute violations of federal law
- Collect data on human trafficking crimes in the Eastern District, inclusive of all cases prosecuted in the district, regardless of originating law enforcement agency
- Assign case managers from social service partners to provide case management services to victims

St. Louis County Police Department and St. Charles County Sheriff's Department agree to the following:

- Conduct proactive investigations of human trafficking crimes in the Eastern District of Missouri
- Ensure law enforcement personnel in region are adequately trained in protocols related to human trafficking
- Provide leadership in the development of a law enforcement agency-coordinated response to case investigations
- Provide on-going community education
- Document all program and service activities, coordinating data reporting with International Institute of St. Louis

International Institute of St. Louis agrees to the following:

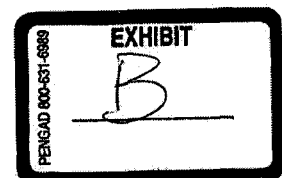
- Provide case management for identified victims and build coordinated system of services with other agencies
- Contribute to professional literature, promising practice compendiums and regional or national conferences
- Develop protocols for area agencies to ensure systematic and comprehensive victim services
- Track data for reporting purposes

Legal Services of Eastern MO agrees to the following:

- Provide civil legal services to low-income domestic or immigrant victims of human trafficking, as identified by federal law enforcement, consistent with Program Priorities and Legal Services Corporation funding guidelines
- Document program activities relevant to the sub-award, including submission of reports on a timely basis
- Contribute to professional literature, promising practice compendiums and regional or national conferences

YWCA agrees to the following:

- Provide case management for identified sex trafficking victims and coordination of services with other agencies
- Contribute to professional literature, promising practice compendiums and regional or national conferences

CONTRACT

THIS AGREEMENT between ST. LOUIS COUNTY, MISSOURI on behalf of the St. Louis County Department of Police (hereinafter after "ST. LOUIS COUNTY"), and the COUNTY OF ST. CHARLES, MISSOURI on behalf of the St. Charles County Sheriff's Department (hereinafter "ST. CHARLES COUNTY").

WHEREAS, St. Louis County's Police Department maintains a Multijurisdictional Human Trafficking Task Force which, among other things, engages in undercover activities; and

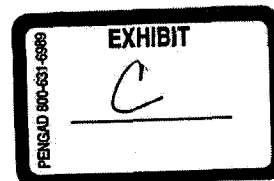
WHEREAS, ST. CHARLES COUNTY wishes to assign one detective of the St. Charles County Sheriff's Department to St. Louis County's Multijurisdictional Human Trafficking Task Force upon the terms stated herein; and

WHEREAS, the St. Louis County Executive is authorized by Ordinance No. _____, 2014 to enter into such an AGREEMENT on behalf of the ST. LOUIS COUNTY;

WHEREAS, ST. CHARLES COUNTY is authorized to enter into this agreement pursuant to St. Charles County's Ordinance Number _____.

NOW THEREFORE, in consideration of the premises and promises contained herein, the parties agree as follows:

1. The ST. CHARLES COUNTY agrees to provide ST. LOUIS COUNTY with the services of one (1) detective (hereinafter "Detective"), who is mutually agreeable to both parties for the remainder of the two year grant period, which commenced on 10/01/13 and terminates on 09/30/15.
2. The Detective will be under the direct supervision and control of the St. Louis County Police Department.
3. The Detective will be subject to the St. Louis County Police Department's rules and regulations, including, but not limited to, random drug testing.
4. The Detective will be deputized under the St. Louis County Deputization Manual.
5. ST. LOUIS COUNTY will reimburse ST. CHARLES COUNTY for the Detective's salary, benefits, not to



exceed \$115,012.96 over the grant period listed in paragraph 1. ST. CHARLES COUNTY remains responsible for the Detective's overtime accrued, workers' compensation benefits and transportation.

6. ~~Either party to this agreement may cancel this agreement with thirty (30) days' written notice. Notice to ST. LOUIS COUNTY shall be deemed delivered if deposited, postage prepaid, addressed to Chief of Police, St. Louis County Police Department, 7900 Forsyth Boulevard, Clayton, Missouri 63105. Notice to ST. CHARLES COUNTY shall be deemed delivered if deposited, postage prepaid, addressed to Sheriff's Department - St. Charles County, 101 Sheriff Dierker Court, O'Fallon, Missouri 63366.~~

7. ST. CHARLES COUNTY shall be entitled to a portion of assets forfeited federally as a result of Multijurisdictional Human Trafficking Task Force operations conducted during the period Detective is assigned to the St. Louis County's Multijurisdictional Human Trafficking Task Force, regardless of the location where such assets were seized. The portion shall be computed as of the time of seizure and not the time of distribution. The portion shall be determined by multiplying the assets forfeited by the following ratio:

(Number of detectives assigned by ST. CHARLES COUNTY to St. Louis County's Multijurisdictional Human Trafficking Task Force)

(Total number of Detectives from all sources assigned to St. Louis County's Multijurisdictional Human Trafficking Task Force.)

ST. LOUIS COUNTY may increase or decrease the number of detectives assigned to the Multijurisdictional Human Trafficking Task Force without approval of ST. CHARLES COUNTY. ST. LOUIS COUNTY may also enter into similar agreements with other municipalities which will affect the number of detectives assigned to the Multijurisdictional Human Trafficking Task Force from all sources and thereby affect the portion of the forfeited assets to which ST. CHARLES COUNTY will be entitled.

8. ST. CHARLES COUNTY will cooperate with ST. LOUIS COUNTY in preparing the proper documentation for the courts, prosecutors and other law enforcement agencies so that the forfeited assets owed to ST. CHARLES COUNTY are not deposited in a general revenue account of ST. LOUIS COUNTY, but are paid directly to ST. CHARLES COUNTY instead.

9. ST. LOUIS COUNTY will provide the necessary specialized equipment for undercover activities, including radio equipment, and other specialized surveillance equipment.

10. All necessary evidentiary and expense funds will be provided by ST. LOUIS COUNTY.

11. The Supervisor of the St. Louis County's Multijurisdictional Human Trafficking Task Force will submit a performance evaluation to ST. CHARLES COUNTY regarding the performance of the participating ST. CHARLES

COUNTY detective once every twelve (12) months.

12. ST. CHARLES COUNTY shall provide proof of Commercial General Liability Insurance in compliance with the sovereign immunity limits for Missouri public entities, which are calculated by the Missouri Department of Insurance and published annually in the Missouri Register within three days of request by ST. LOUIS COUNTY. This coverage shall also apply to Civil Rights Claims that may arise. ST. LOUIS COUNTY shall remain self-insured regarding claims. ST. CHARLES COUNTY shall maintain during duration of this agreement Workers' Compensation Insurance. *For those self-insured agencies: A letter of self-insurance with unencumbered balances that meets the statutory cap on a per occurrence basis will be accepted in lieu of Certificate of Insurance.*
