

**ORDINANCE OF THE TOWNSHIP OF DEPTFORD AUTHORIZING A  
SPECIAL EMERGENCY APPROPRIATION FOR THE PREPARATION OF A  
MASTER PLAN**

**WHEREAS**, N.J.S.A. 40A:5-53(d) provides for a municipality to adopt by ordinance special emergency appropriations for the engagement of special consultants for the preparation and reexamination of master plans when required to conform to the planning laws of the State of New Jersey; and,

**WHEREAS**, N.J.S.A. 40:55D-89 provides that each municipality shall perform a re-examination of its master plan at least every ten (10) years; and,

**WHEREAS**, the Township of Deptford, having completed the last Master Plan revisions in November 2007, believes to properly facilitate growth and development of the Township it should complete a Master Plan review and revision in 2015; and

**WHEREAS**, the estimated cost of the engagement of special consultants for the preparation of a master plan is \$100,000.00;

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Township of Deptford, County of Gloucester and State of New Jersey as follows:

- 1 – In accordance with N.J.S.A. 40A:4-53(d), a special emergency appropriation is hereby authorize for the purpose of carrying out the re-examination and revision of the Township of Deptford Master Plan, as mandated by N.J.S.A. 40:55D-89 and shall be deemed a special emergency appropriation in the amount of \$100,000.00.
- 2 – The authorization to finance the appropriation shall be provided for in succeeding annual budgets by the inclusion of at least one fifth of the amount authorized by this ordinance and as provided in N.J.S.A. 40A-55(c).
- 3 – A copy of this ordinance shall be filed with the Director of the Division of Local Government Services five (5) days after final passage.
- 4 – This ordinance shall take effect upon final passage and publication as required by law.
- 5 – All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.




