ORDINANCE OF THE TOWNSHIP OF DEPTFORD AMENDING 0.16.15 SPECIAL EMERGENCY APPROPRIATION FOR THE PREPARATION OF A MASTER PLAN

WHEREAS, the Township Council of the Township of Deptford adopted Ordinance O.16.15 establishing a special emergency appropriation for the preparation of a Master Plan,

WHEREAS, the true estimation of the cost of the preparation of the Master Plan is \$175,000.00 and the Township Council deems it necessary to appropriate the additional \$75,000.00 for the payment of professionals retroactive to the original adoption date; and,

NOW THEREFORE, BE IT ORDAINED by the Mayor and Council of the Township of Deptford, County of Gloucester and State of New Jersey as follows:

- 1 In accordance with N.J.S.A. 40A:4-53(d), a special emergency appropriation is hereby authorize for the purpose of carrying out the re-examination and revision of the Township of Deptford Master Plan, as mandated by N.J.S.A. 40:55D-89 and shall be deemed a special emergency appropriation in the amount of \$175,000.00.
- 2 The authorization to finance the appropriation shall be provided for in succeeding annual budgets by the inclusion of at least one fifth of the amount authorized by this ordinance and as provided in N.J.S.A. 40A-55(c). Of which, the Township has appropriately appropriated one-fifth of \$175,000.00 in the 2016 adopted budget.
- 3 A copy of this ordinance shall be filed with the Director of the Division of Local Government Services five (5) days after final passage.
- 4 This ordinance shall take effect upon final passage and publication as required by law.
- 5 All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.
