## ORDINANCE OF THE TOWNSHIP OF DEPTFORD AMENDING THE UNIFIED DEVELOPMENT ORDINANCE (UDO) TO REVISE THE ZONING MAP IN BLOCK 6 (RT. 47) OF THE TAX ASSESSMENT MAPS OF THE TOWNSHIP OF DEPTFORD, COUNTY OF GLOUCESTER, STATE OF NEW JERSEY

WHEREAS, the Township Council of the Township of Deptford, a municipal corporation in the County of Gloucester, State of New Jersey, finds that the public health, safety, morals, and general welfare of the community shall be promoted by the revision and amendment of the Zoning Map of the Township; and

WHEREAS, the Planning Board of the Township of Deptford has adopted a Master Plan, adopted on January 11, 2017, that comprehensively provides for the appropriate use and development of lands in the Township in a manner which will promote the public health, safety, morals, and general welfare; and

WHEREAS, the Municipal Land Use Law at *N.J.S.A.* 40:55D-62a requires substantial consistency of the provisions regulating zoning and land use with the adopted Land Use Plan Element; however, a governing body may adopt a zoning ordinance or zoning map wholly or partly inconsistent with such land use plan element provided that the reasons for so doing are set forth in a resolution and recorded in its minutes; and

WHEREAS, the Planning Board has determined that the revision to the Zoning Map is consistent with the recently adopted Land Use Plan Element and it is supported by the goals of the Master Plan; and

WHEREAS, the Zoning Map revision represents sound land use planning and therefore favorably recommends to the Township Council that the Zoning Map be so amended; and

WHEREAS, this ordinance effectuates a classification and boundary change recommended in a periodic general reexamination of the master plan pursuant to *N.J.S.A.* 40:55D-89; and

WHEREAS, the Township Council has determined that the rezoning of this property from the Office (O) to the Transitional Commercial 1 (TC-1) district will permit not only the office uses allowed in the Office Zone but retail sale of goods and personal services; and

WHEREAS, the TC-1 district as applied to Block 6, Lot 11 will be able to supply such retail sales and services to the Westville Grove neighborhood in addition to professional office and other office uses benefitting the area.

NOW, THEREFORE, BE IT ORDAINED, by the Township Council of the Township of Deptford that the Unified Development Ordinance (UDO) be hereby amended as follows:

Section 1. Purpose. The Township of Deptford, as a municipality in the State of New Jersey,

hereby declares that pursuant to the purposes of the New Jersey Municipal Land Use Law, N.J.S.A. 40:55D-2, that the amendments contained herein shall promote for good civic design and arrangement, while continuing to promote the establishment of appropriate land uses to avoid congestion and blight and thereby contributing to the well-being of persons, neighborhoods, the community and region as a whole.

Section 2. §7.B, Establishment of Zoning Districts and Zoning Map, shall be amended to apply the TC-1 zoning district to Block 6, Lot 11 and the Zoning Map shall be revised with the date of adoption, herein.

Section 3. Continuation. In all other respects, the Unified Development Ordinance of the Township of Deptford shall remain unchanged.

Section 4. Severability. If any portion of this Ordinance is for any reason held to be unconstitutional or invalid by a court of competent jurisdiction, such decision shall not affect the validity of this Ordinance as a whole, or any other part thereof. Any invalidation shall be confined in its operation to the section, paragraph, sentence, clause, phrase, term, or provision or part there of directly involved in the controversy in which such judgment shall have been rendered.

Section 5. Interpretation. If the terms of this Ordinance shall be in conflict with those of another Ordinance of the Code of the Township of Deptford, then the restriction which imposes the greater limitation shall be enforced.

Section 6. Repealer. All ordinances or parts of ordinances which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency only.

Section 7. Enactment. This Ordinance shall take effect upon the filing thereof with the Gloucester County Planning Board after final passage, adoption, and publication by the Township Council of the Township of Deptford in the manner prescribed by law.
