ORDINANCE OF THE TOWNSHIP OF DEPTFORD AUTHORIZING THE SALE OF PROPERTY WITH AN ADDRESS OF 191 ANDALORO WAY AND MORE SPECIFICALLY KNOWN AS BLOCK 11, LOT 1 ON THE TAX MAP OF DEPTFORD TOWNSHIP

WHEREAS, the Township of Deptford (the "Township") owns property located at 191 Andaloro Way and known more specifically as Block 11, Lot 1 on the Tax Map of Deptford Township (the "Property"); and

WHEREAS, the Property is undersized and cannot be developed without the approval of variances; and

WHEREAS, it has been determined by the Township Engineer that there is no public purpose for the Township to retain the Property; and

WHEREAS, pursuant to the New Jersey Local Land and Buildings Law, N.J.S.A. 40A:12-13(b)(5) (the "Law"), Seller, as a municipality governed by the Law, has the legal right to convey this real property to Phyllis DeLuca (the "Buyer"), without the need to put the Property up for sale through a public bidding process because the Property is a non-confirming parcel of ground that has been offered to all adjoining property owners with only Buyer having any interest in purchasing this parcel; and

WHEREAS, all ordinances of the Township of Deptford which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency; and

WHEREAS, if any subsection, sentence, clause, or phrase of this Ordinance is for any reason held to be unconstitutional or invalid in any Court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance; and

WHEREAS, this Ordinance shall take effect upon final passage, approval, and publication, as required by law.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Township Council of the Township of Deptford, County of Gloucester, State of New Jersey that the Township is authorized to sell the Property to Buyer for the amount of Two Thousand- Dollars (\$2,000.00).

BE IT FURTHER ORDAINED that the Mayor, Township Manager and/or other appropriate Township officials are hereby authorized to take all actions to complete this transaction including, but not limited to execution of an Agreement of Sale and Deed for the Property.
