A local law Adding Chapter 211 to the Code of the Incorporated Village of East Rockaway relating to Business Licenses

#### Section 1. Legislative Intent

This Local Law adds Chapter 211 to the Code of the Incorporated Village of East Rockaway. This Chapter sets forth the application process for obtaining and renewing a business permit, which will now be required for any person operating a business within the Village.

#### Chapter 211

#### **Business Licenses**

#### 211.1 License required.

No person shall conduct any business in the Village without obtaining a license as provided in this Chapter and in Chapter 187, License and Permits.

211.2 License fee and renewal.

A. The annual license fee shall be twenty-five (\$25.00) dollars.

B. All business licenses shall expire on the 31<sup>st</sup> day of December next succeeding the date of issuance thereof, unless sooner revoked or suspended. A new application for license must be made yearly if the licensee desires to continue the retail business.

#### 211.3 License required.

It shall be unlawful for any person to operate a business without a license therefor.

#### 211.4 Display of licenses.

All licenses shall be placed and at all times displayed in a conspicuous place at the licensee's place of activity for which it is issued.

#### 211.5. Licenses non-transferable.

All retail business licenses are personal with the licensee. The license may not be sold, assigned or transferred.

211.6 License application and issuance.

A. Applicants for a license under this Chapter must file with the Village Clerk of the Village of East Rockaway an application, supplied by the Village Clerk, containing all the information requested therein.

B. Upon receipt of the license application, payment of the license fee and upon the approval by the Village Clerk of the Village of East Rockaway, the Village Clerk shall prepare and deliver to the applicant the license.

C. Every license issued hereunder shall be signed and sealed by the Village Clerk.

D. The Village Clerk shall keep a record of all business licenses issued.

#### Section 3. Severability

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

#### **Section 4. Effective Date**

This local law shall take effect immediately upon filing with the Secretary of State.
