Section 1. Legislative Intent

It is the intent of this local law to allow the Village of East Rockaway to adopt a budget for the fiscal year commencing 2022 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law § 3-c., which this year is 2%.

Section 2. Authority

This local law is adopted pursuant to subdivision 5 of General Municipal Law § 3-c, which expressly authorizes a local government's governing body to override the tax levy limits for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of the Village Board of Trustees.

Section 3. Tax Levy Limit Override

This Board of Trustees of the Village of East Rockaway, County of Nassau, is hereby authorized to adopt a budget for the fiscal year commencing 2022 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal law § 3-c.

Section 4. Severability
