#### **Section 1. Legislative Intent**

It is the intent of this local law to amend Section 6-3 of the Village Code as to allow a person to be elected to three (3) consecutive terms. The current law only allows a person to be elected to two (2) consecutive terms.

#### Section 2. Section 6-3 as Amended:

No person shall be elected to the office of Trustee for more than three full consecutive terms.

#### **Section 3. Severability**

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

#### **Section 4. Effective Date**

This local law shall take effect immediately upon filing with the Secretary of State.
