§6-12 Salaries for Elected Officials

The annual salaries for elected officials of the Village of East Rockaway shall be as follows:

A. Mayor: \$20,000.00B. Trustees: \$15,000.00C. Village Justice; \$12,500.00

Section 3. Severability
