Section 1. Legislative Intent

This Local Law amends Section 288-112 B of the Code so as to clarify what can be sold in the Industrial B Zone under the definition of a "Head Shop."

Section 2. Section 288-112 B

Head Shop

An establishment having any portion of its stock-in trade in drug-related paraphernalia or accoutrements, vape products, liquid nicotine, powdered tobacco, bidis, gutka, shisha, cannabis, cannabinoids, CBD, hookah items or any similar products.

Section 3. Severability

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 4. Effective Date

This local law shall take effect immediately upon filing with the Secretary of State.
