### ARTICLE 20 AS WRITTEN IN THE SUPPLEMENT:

Deletions to the existing Zoning Code are shown as strike-through, additions to the existing Zoning Code are shown in *italics*. Only the sections of the Zoning Code affected by the proposed amendments are shown; with all other sections of the Zoning Code remaining unchanged.

#### <u>ARTICLE (20): ZONING AMENDMENT §235 – House Keeping to Correct Typos</u> Correction 1 of 2 - APPENDIX A-1 Traditional Zoning Districts Table of Use Regulations

<u>Purpose</u>: This is a housekeeping item. In many instances under the Industrial Zone (I) column the special permit granting authority was truncated from "ZBA" (Zoning Board of Appeals) to "ZB".

<u>Change</u>: Correct APPENDIX A-1 Traditional Zoning Districts Table of Use Regulations to properly reference the Zoning Board of Appeals as "ZBA" in the I (Industrial Zone). As an example:
