The City of Eldon Board of Aldermen has declared certain personal property to be surplus and is soliciting sealed bids for the property listed below.


Parcel 038034004001002006 located off Freeport Street and Olympic Street, in the Jones Subdivision.



"Beginning" at the southeast corner of said undivided block, said corner being located at the intersection of the north line of Olympic Street with the west line of Freeport Avenue; thence westerly along the north line of Olympic Street for a distance of 210.0 feet; thence northerly, parallel with the west line of said Freeport Avenue for 360.0 feet; thence easterly, parallel with the north line of Olympic Street for 210.0 feet to a point on the west line of said Freeport Avenue; thence southerly along said west line of Freeport Avenue for 360.0 feet to the point of "Beginning", containing 1.73 acres, more or less, and being subject to or having the benefit of easements and/or restrictions of record or not of record. ** NOTE: (The writer of this description believes that the 'replat' first above mentioned incorrectly shows the east and west side of this undivided block to be 410 feet in length. The writer believes the replat intended this block to be the same 360- foot length as the original blocks. See also the original plat of "Jones Subdivision" filed for record in Plat Book 4 of the Miller County Records.)
