The Town Code should be amended at Sect. 200-30(c)(1) (Nonconforming uses and structures) to add/include subsection (c) as follows:

(c) Application for Certification of Nonconformity. An applicant may apply directly to the Planning Department for a Certificate of Nonconformity, used to determine: pre-existing rights to a nonconforming use or structure; the potential change from one nonconforming use to another nonconforming use; re-use and/or renovation of a previous nonconforming structure; or to extend a period of vacancy due to extensive rehabilitation of a structure, subject to the following:

- ???[1] Submittal of documentation required for consideration of the application, including but not limited to survey maps, scaled site plans, aerials, surveys, and images; and
- ???[2] The nonconforming use/structure has not been discontinued for a two-year period; and
- [3] The nonconforming use/structure is not intentionally abandoned; and
- [4] There are no violations from the applicable federal, state, county, and local laws, codes, ordinances, and regulations, including any required approvals or permitting; and
- [5] An application fee set by resolution of the Town Board and as set forth in Chapter 106, Fees.


