REZONE – From Rural Residential (RR) to Rural Agriculture (RA)

ALL THAT TRACT OR PARCEL OF LAND, situate in the Town of Evans, County of Erie and State of New York, being part of Lot 49, in the 8th Township and 9th Range of the Holland Land Company's Survey and being further bounded and described as follows:
