RESOLUTION NO. 79-2023**

Whereas the Town of Geneva receives dog control services through Ontario County, contracting with the Ontario County Humane Society; and

Whereas the County has increased the price per dog charged to the Town to \$21.50, effective January 1, 2024; and

Whereas the Town has been charging \$20.00 for neutered and spayed dogs, with \$1.00 going to the state, and \$25.00 for un-spayed and un-neutered dogs, with \$3.00 going to the state, so the Town must raise its dog license fees to cover the cost of the new contract with the County and the Town's administrative expenses; now therefore, it is

RESOLVED, beginning January 1, 2024, the cost of a dog license in the Town of Geneva will be \$25.00 for spayed and neutered dogs, and \$30.00 for un-spayed and un-neutered dogs.
