THE TOWN BOARD having held a public hearing on the 3rd day of January, 2024 at 2:00 p.m. to consider adopting Local Law Introductory No. 46-2023 amending the Uniform Traffic Code of the Town of Huntington, Chapter 3, Article II, §3-3, Schedule J, and due deliberation having been had; and

WHEREAS, the installation of parking signs is a Type II action pursuant to 6 N.Y.C.R.R. 617.5(c)(22) and, therefore, no further review is required.

HEREBY ADOPTS

Local Law Introductory No. 46-2023 amending the Uniform Traffic Code of the Town of Huntington, Chapter 3, Article II, §3-3, Schedule J, as follows:

BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF HUNTINGTON, AS FOLLOWS:

AMENDING THE TRAFFIC CODE OF THE TOWN OF HUNTINGTON
CHAPTER 3, ARTICLE II, §3-3, SCHEDULE J

Section 1. Amendment to the Uniform Traffic Code of the Town of Huntington, Chapter 3, Article II, §3-3, Schedule J, as follows:

CHAPTER 3, ARTICLE II, §3-3, SCHEDULE J

<u>NAME OF STREET/SIDE LOCATION</u>	<u>REGULATION</u>	<u>HOURS/DAYS</u>
DELETE: East Twelfth Street/North From 350 ft. east of New York Ave. to New York Ave. (HUS)	No Parking	-----
East Twelfth Street/South From New York Ave. east for 350 ft. (HUS)	No Parking	-----
ADD: East Twelfth Street/North From 350 ft. east of New York Ave. to New York Ave. (HUS)	No Stopping	-----
East Twelfth Street/South From New York Ave. east for 350 ft. (HUS)	No Stopping	-----

Section 2. Severability.

If any clause, sentence, paragraph, subdivision, section, or other part of this local law shall for any reason be adjudged by any court of competent jurisdiction to be unconstitutional or otherwise invalid, such judgment shall not affect, impair or invalidate the remainder of this local law, and it shall be construed to have been the legislative intent to enact this local law without such unconstitutional or invalid parts therein.

Section 3. Effective Date.

This local law shall take effect immediately upon filing in the Office of the Secretary of the State of New York.
