WHEREAS, the Municipal Home Rule Law of the State of New York and Chapter 26 of the Code of the Town of Lancaster provide for the adoption and enactment of local laws; and

WHEREAS, a proposed Local Law of the year 2023 revising the Town of Lancaster Code, Noise, to change the wording in Section 221-7 Exceptions, Subsection D, was introduced to the Town Board of the Town of Lancaster by Council Member Leary on the 7th day of August, 2023; and

WHEREAS, the Town Board, acting as Lead Agency under the State Environmental Quality Review Act ("SEQRA") has determined the action is a Type I action and has issued a negative declaration; and

WHEREAS, the Town Board called for, noticed, and held a public hearing on the proposed Local Law on August 21, 2023, where all interested parties were allowed to address the proposed Local Law.

NOW, THEREFORE,

BE IT RESOLVED, by the Town Board of the Town of Lancaster that:

1. The attached Local Law No. 3 of 2023 is hereby adopted.
2. The Local Law shall be effective upon its filing with the Secretary of State pursuant to the Municipal Home Rule Law.

**Town of Lancaster
Local Law No.: 3 of 2023**

**Local Law Amending Chapter §221-7 of the Town Code of the Town of Lancaster to
Change the Time Sound Exceptions Shall be Allowed.**

Be it hereby enacted by the Town Board of the Town of Lancaster as follows:

§221-7 Exceptions

D. The sound created by sporting events, public organizations, private schools, carnivals, fairs, exhibitions, picnics, or parades, provided that such events shall take place between the hours of 7:00 a.m. and 11:00 p.m.
