***AN ORDINANCE AUTHORIZING THE MAYOR OR HIS DESIGNATED AGENT TO
ENTER INTO A CONTRACT WITH LEXIPOL FOR ONLINE POLICE TRAINING***

WHEREAS, the City of Lake Ozark, Missouri has a police department that is tasked with professionally serving and protecting the citizens and visitors to the City; and

WHEREAS, the City has solicited and received a proposal from LEXIPOL to provide the department's officers with online training; and

WHEREAS, it is in the best interest of the City of Lake Ozark, Missouri that the Board of Aldermen authorize the Mayor to contract with LEXIPOL as per the contract attached hereto as Exhibit A.

Now, therefore, be it ordained by the Board of Aldermen of the City of Lake Ozark, Missouri, as follows:

Section 1. Approval of Agreement. The contract with LEXIPOL is hereby approved in the form submitted to and reviewed by the Board of Aldermen on the date hereof.

Section 2. Execution: The Mayor or his designated agent is hereby authorized and directed to execute and deliver the contract on behalf of and as the act and deed of the City of Lake Ozark.

Section 3. Further Authority. The Mayor, and the designated officials and agents of City of Lake Ozark are hereby authorized and directed to, take such action, expend such budgeted funds and execute such other documents, certificates and instruments as may be necessary or desirable to carry out and comply with the intent of this Ordinance and to carry out, comply with and perform the duties of the City of Lake Ozark with respect to the contract.

Section 4. Effective Date. This ordinance shall take effect and be in full force from and after its adoption by the Board of Alderman.
