AN ORDINANCE AMENDING THE OPERATIONAL POLICIES OF THE LAKE OZARK POLICE DEPARTMENT

WHEREAS, the Chief of Police has determined that several existing Operational Guidelines of the Department are in need of updating to serve the best interests of the operations of the Department and safety of the community; and
