***AN ORDINANCE AMENDING THE OPERATIONAL POLICIES OF THE  
LAKE OZARK POLICE DEPARTMENT***

**WHEREAS** the City of Lake Ozark maintains a police force to serve and protect the lives and property the City's citizens; and

**WHEREAS**, to assure the professionalism and training of said force, the Police Department has adopted various Operational Policies to govern the conduct of the organization and individuals working in the Department; and

**WHEREAS**, the Chief of Police has determined that several existing Operational Guidelines of the Department are in need of updating to serve the best interests of the operations of the Department and safety of the community; and

**WHEREAS** the Chief of Police recommends updating of the Department's Operational Guidelines by the adoption of the following policies attached hereto as Exhibit 1 to govern the following:


