ORDINANCE NO. 12 -2023

AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE TOWNSHIP OF LOGAN COUNTY OF GLOUCESTER, STATE OF NEW JERSEY, AMENDING CHAPTER 4 ENTITLED "ADMINISTRATION OF GOVERNMENT" TO THE CODE OF THE TOWNSHIP OF LOGAN

WHEREAS, the Mayor and Council of the Township of Logan have determined that certain amendments to Chapter 4 entitled "Administration of Government" are necessary; and

WHEREAS, in all other respects Chapter 4 entitled "Administration of Government" shall remain in full force and effect;

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Township of Logan, in the County of Gloucester and State of New Jersey, and it is hereby enacted and ordained by the authority of same as follows:

Section 1.

Article X entitled "Department of Police" of Chapter 4 entitled "Administration of Government" shall be amended as follows:

Article X. Department of Police.

- § 4-47. Supervision; composition; powers and duties; intermunicipal assistance.
- G. Off-duty employment.
 - (4) Rates of compensation; administrative fee; payment for services.
 - (a) Rate of compensation for contracting the services of off-duty law enforcement officers are established as follows:
 - [1] Rate of compensation, per hour: \$70 rate shall be established per the Logan Township Police Department Extra Duty Fee Schedule adopted annually via Resolution by the Logan Township Council.
 - [a] After eight hours of work on the same day by the same officer, the officer's pay rate shall increase to \$80 per hour per the Logan Township Police Department Extra Duty Fee Schedule adopted annually via Resolution by the Logan Township Council.
 - [b] If the contractor cancels any work detail within two hours of the assigned start time, the contractor is responsible to compensate the assigned officer(s) a two-hour minimum pay rate and administrative fees.
 - [c] If the contractor starts the work detail and cancels the job after starting, the contractor is responsible to compensate the assigned officer(s) a minimum of four hours of pay and administrative costs.

- [2] Rate per day for use of police vehicle: \$80; rate per half-day use of police vehicle: \$40 shall be per established the Logan Township Police Department Extra Duty Fee Schedule adopted annually via Resolution by the Logan Township Council.
- [3] An additional fee of 20% of the total cost of compensation and use of vehicle to the contracting unit is hereby established to cover administrative costs, overhead, and out-of-pocket expenses of the Township of Logan.

Section 2.

Severability.

Should any section, clause, sentence, phrase or provision of this Ordinance be declared unconstitutional or invalid by a Court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

Section 3.

Repealer.

All prior Ordinances or parts of Ordinances inconsistent with this Ordinance be and the same are hereby repealed to the extent of such inconsistencies.

Section 4.

When effective.

This Ordinance shall take effect immediately upon final passage and publication in accordance with law.
