ORDINANCE NO. 18 -2023

AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE TOWNSHIP OF LOGAN, COUNTY OF GLOUCESTER, STATE OF NEW JERSEY, AMENDING SECTION 152 ENTITLED "VEHICLES AND TRAFFIC" OF THE UNIFIED DEVELOPMENT ORDINANCE OF THE TOWNSHIP OF LOGAN

WHEREAS, the Mayor and Council of the Township of Logan have determined that certain amendments to Chapter 152 entitled "Vehicles and Traffic" are necessary; and

WHEREAS, in all other respects Chapter 152 entitled "Vehicles and Traffic" shall remain in full force and effect;

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Township of Logan, County of Gloucester and State of New Jersey, and it is hereby enacted and ordained by the authority of same as follows:

Section 1. Section 152.7, entitled, "Parking prohibited at all times" shall be amended as follows:

§152-7. Parking prohibited at all times.

A. No person shall park a vehicle at any time upon any of the streets or parts thereof described as follows:

Section 3. Severability.

Should any section, clause, sentence, phrase or provision of this Ordinance be declared unconstitutional or invalid by a Court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held to be invalid or unconstitutional by a Court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

Section 5. When effective.

This Ordinance shall take effect immediately upon final passage and publication in accordance with law.
