ORDINANCE NO. <u>1</u>-2024

AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE TOWNSHIP OF LOGAN COUNTY OF GLOUCESTER, STATE OF NEW JERSEY, AMENDING CHAPTER 92 ENTITLED "FEES AND CHARGES" TO THE CODE OF THE TOWNSHIP OF LOGAN

WHEREAS, the Mayor and Council of the Township of Logan have determined that certain amendments to Chapter 92 entitled "Fees and Charges" are necessary; and

WHEREAS, in all other respects Chapter 92 entitled "Fees and Charges" shall remain in full force and effect;

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Township of Logan, in the County of Gloucester and State of New Jersey, and it is hereby enacted and ordained by the authority of same as follows:

Section 1.

Chapter 92 entitled "Fees and Charges" shall be amended to include a new Article VII as follows:

Article VII. Athletic Field Application Fees.

The following fees shall apply to applications for use of Logan Township athletic fields:

- 1. Category 1. No Fee.
- 2. Category 2. No Fee.
- 3. Category 3. \$10 per participant, per team for up to a 13-week season.
- 4. Category 4. \$25, plus 5% of the gross revenue generated by the camp/clinic shall be due within thirty (30) calendar days of the date the camp/clinic has concluded.
- 5. Category 5.
 - a. With less than 250 total participants: \$100 per field or court per day.
 - b. With 250 or more total participants: \$500 per day, plus \$100 per field or court per day.

A fifty percent (50%) down payment is required with submission of the Category 5 tournament request form. The balance shall be due within seven (7) calendar days after Township Council approval. If Township Council denies the application, the down payment shall be refunded.

Section 2.

Severability.

Should any section, clause, sentence, phrase or provision of this Ordinance be declared unconstitutional or invalid by a Court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

Section 3.

Repealer.

All prior Ordinances or parts of Ordinances inconsistent with this Ordinance be and the same are hereby repealed to the extent of such inconsistencies.

Section 4.

When effective.

This Ordinance shall take effect immediately upon final passage and publication in accordance with law.
