

**EXTRACT OF MINUTES OF A REGULAR MEETING OF THE BOARD OF TRUSTEES OF THE VILLAGE  
OF MAMARONECK HELD ON DECEMBER 11, 2023, AT 8:00 P.M.  
IN THE COURTROOM AT 169 MT. PLEASANT AVENUE**

**RESOLUTION RE:  
ESTABLISHING FEES & CHARGES FOR THE 2024 BOATING SEASON**

WHEREAS, on an annual basis, Village staff reviews its fees and charges schedules in preparation of the Tentative Budget filed on March 20th of each year; and

WHEREAS, certain fees are more time sensitive, and it is appropriate that they be approved in advance of the Budget adoption as the Village needs to advertise and prepare printed materials incorporating said information, an example being fees which are more seasonal in nature such as dock and mooring fees; and

WHEREAS, in order for the Harbor Master to begin the process of issuing renewal permits, which typically occurs during the winter months, Village staff has prepared fee recommendations for the 2024 boating season, said fees having been **reviewed** by the Board of Trustees at their November 27, 2023, work session; and

WHEREAS, among the suggested recommendations is a general two percent (2%) increase to resident fees and non-resident fees, and a seven percent (7%) increase to mooring fees which have not been increased since 2020,

NOW THEREFORE BE IT RESOLVED, that the current fees set forth in Chapter A347 of the Code of the Village of Mamaroneck associated with Chapter 240 of the Village Code are deleted, and the following updated schedule for fees associated with Chapter 240 of the Village Code are adopted under Chapter A347, as attached hereto and made a part hereof.
