**AN ORDINANCE OF THE TOWNSHIP OF MANSFIELD, WARREN COUNTY, NEW JERSEY
APPROPRIATING \$700,000.00 FROM THE GENERAL CAPITAL RESERVE FUND FOR THE
PURPOSE OF PURCHASING FIRE APPARATUS**

BE IT ORDAINED BY THE TOWNSHIP OF MANSFIELD, IN THE
COUNTY OF WARREN, NEW JERSEY AS FOLLOWS:

Section 1. \$700,000.00 is available from the Capital Reserve Fund to
provide for the following purposes:

hereof as provided by N.J.S.A. 40:49-9.
