

MENOMINEE NATION MENOMINEE TRIBAL LEGISLATURE MTL AMENDMENT #6 TO ORDINANCE NO. 22-42 FISCAL YEAR 2023 APPROPRIATIONS

FINAL APPROVAL

BE IT ORDAINED BY THE LEGISLATURE OF THE MENOMINEE INDIAN TRIBE OF WISCONSIN:

- **1. PURPOSE.** This amendment increases the Fiscal Year 2023 Appropriations by \$32,318 as follows:
 - 1.01 \$32,318 for Land Management to pay for Archeological surveys of 40 trust lots;
 - 1.02 Increase Wolf River Development Corporation (WRDC) by \$71,815;
 - 1.03 Decrease transfer from Tribe's general fund by \$39,497.
- 2. This amendment increases the total Appropriations of \$27,542,702 to \$27,575,020.
- 3. AMENDMENT. The tabular summary of anticipated fund revenues and expenditures, entitled EXHIBIT "A", which was attached to and made a part of Menominee Tribal Ordinance No. 22-42, entitled "Fiscal Year 2023 Appropriations", is hereby replaced in its entirety with the attached revision. All other terms, conditions, and provisions of Ordinance No. 22-42 not specifically listed in this amendment are unchanged and unaffected.
- **4. EFFECTIVE DATE.** This amendment shall become effective immediately upon final approval by the Menominee Tribal Legislature.

CERTIFICATION

The undersigned officers of the Menominee Tribal Legislature do hereby certify that the foregoing Ordinance was duly **adopted** at a regular meeting of the Menominee Tribal Legislature held on August 17, 2023, by a vote of 6 for, 0 opposed, 0 abstentions, and 3 absent.

The undersigned also certify that the above Ordinance has been posted in accordance with the Constitution and Bylaws of the Menominee Indian Tribe of Wisconsin.
